Early Career Members Committee Responsibilities

- **Developing early career sessions for the ACS Annual Meeting.**
- **Developing input and recommendations for Early Career Professional Awards.**
 - **Committee members may also serve on the award selection committee for their respective Society.**
- **Preparing monthly articles for *CSA News* magazine on matters relevant to early career members.**
- **Developing and obtaining recommendations on avenues to better serve early career members in their respective Societies and as a whole.**
- **Attending two thirds of meetings yearly.**
- **Failure to meet this requirement will result in removal from the committee by the current chair.**

I hope you will consider being more involved in the Societies from an early career standpoint or check out some of the other amazing ACS committees. No matter where you are in your career, you have a voice that matters and can make an impact if you
